1. Indien graan vir saaddoeleindes verlang word, sal SSK dit hoog op prys stel indien u die inligting sal vasvang op u SSK Kliënte portaal onder "GRAIN \ SEED ORDERS" afdeling, of die vorms voltooi en terugbesorg aan gerdus.steyn@ssk.co.za voor of op **1 Desember 2023**.
2. Saad wat na 1 Desember 2023 bestel word en wat dus spesiaal vir die produsente wat laat bestel het by ander instansies aangekoop word, sal noodgedwonge teen die duurder prys van die aangekoopte saad gefaktureer word.
3. Ingevoerde saad (insluitende Canola saad) waarvan SSK nie die lisensie houër is nie en wat deur SSK aangekoop word kan nie gekanselleer word nie.
4. Saad waarvan SSK die lisensiehouër is, sal toegelaat word om **10%** van die totale bestelling, per kultivar skriftelik te kanselleer, met volgende aanvullende voorwaardes:
 - 4.1 Indien u meer as 10 % van aanvanklike bestelling wil kanselleer of terug lewer aan SSK en waarvan die saad nie weer aan iemand anders verkoop word nie, sal dra koste gefaktureer word en die saad ge-allokeer vir u vir die daaropvolgende plantseisoen en moet derhalwe ingereken word by u saai / plant beplanning.
 - 4.2 Geen grootmaat verpakings, waarvan die seël gebreek is, word teruggeneem vir herverkoop nie. U word aanbeveel om die laaste hoeveelhede van 'n soort in die vorm van klein sakkies (50 kg) te neem, ten einde die oortollige saad te kan terugbring as deel van 10% kansellasie toleransie.
 - 4.3 Saad wat met Flite, Galmano Plus, Celest Top, Biocult of Biocult Rootgaurd behandel word, kan nie gekanselleer of terug gelewer word nie.
5. Alle saad wat met produkte behandel word, wat nie deur SSK gebruik word of ongeregistreer is, word op die produsent se eie risiko gedoen en SSK sal geen verantwoordelikheid dra vir ontkiemings probleme van die saad nie.
6. Die kultivars wat beskikbaar is verskyn op die saadbestellingsvorm.
7. Ontkiemingstoetse sal daagliks tydens die skoonmaakproses gedoen word om te verseker dat 'n hoë standaard gehandhaaf word.

SEED ORDERING FOR COMMERCIAL GRAIN SEED & CANOLA

SSK strives to continuously provide world-class service and products to its members and customers, and a part of this involves optimizing seed purchases and inventory management. Cooperation from producers in this regard is highly important, and you are kindly requested and reminded to take note of the existing arrangements outlined below to enable SSK to manage this process for the benefit of SSK, its members, and customers.

1. If grain is required for seed purposes, SSK would highly appreciate it if you could capture the information on your SSK Client portal under the "GRAIN \ SEED ORDERS" section or complete the forms and return them to gerdus.steyn@ssk.co.za on or before **December 1, 2023**.
2. Seed ordered after December 1, 2023, and therefore specially purchased for producers who place late orders through other institutions, will necessarily be invoiced at the higher price of the purchased seed.
3. Imported seed (including Canola seed) for which SSK is not the license holder and which is purchased by SSK cannot be cancelled.
4. Seed for which SSK is the license holder will be allowed to be cancelled in writing for up to 10% of the total order per cultivar, with the following additional conditions:
 - 4.1 If you wish to cancel or return more than 10% of the initial order, and the seed is not resold to someone else, handling costs will be invoiced, and the seed will be allocated to you for the subsequent planting season and must, therefore, be included in your sowing/planting planning.
 - 4.2 No bulk packaging with a broken seal will be accepted for resale. It is recommended that you take the last quantities of a variety in the form of small bags (50 kg) to facilitate the return of excess seed as part of the 10% cancellation tolerance.
 - 4.3 Seed treated with Flite, Galmano Plus, Celest Top, Biocult, or Biocult Rootguard cannot be cancelled or returned.
5. All seed treated with products that are not used by SSK or are unregistered is done at the producer's own risk, and SSK will not be responsible for germination problems of the seed.
6. The available cultivars will appear on the seed order form.
7. Germination tests will be conducted daily during the cleaning process to ensure a high standard is maintained.
8. No telephone seed orders will be accepted. Only orders placed through the prescribed method as indicated in point 1 will be acceptable.
